The OC have full discretion in the application for training round). Training round will be held immediate after the class and bound by the same competition rules. Same competition course will be used for training round (included the height and width). Entry fee is based on late entry (additional 50% of regular entry fee). Combination may start once in the first round only (included 2nd phase of two-phase competition) and no jump off, 2nd round or winner round will be arranged. Training round will not offer prize, prize money and or grading points and the scores will not show on the official results.

**Any member who wishes to compete in local ranking competitions of affiliated shows from 1st September to 31st August will be required to pay a Rider Registration Fee of HK\$ 400 and a Horse Registration Fee of HK\$400 for his or her competition horse before the start of the local ranking competition which he or she has submitted entries to the OC. Affiliated shows refer to shows organized by the HKEF or other riding schools in accordance with HKEF Rules, or in the case of international competitions, under the Rules of the FEI.

OTHER REGULATIONS

其他規例

1. Liabilities

All athletes will participate in the Event under their own risk. Their participation confirms their acknowledgement that in case of an accident during the event or a training session they disclaim the enactment of any civil rights which may arise against other athletes participating in the event or the training session.

責任

參加賽事的所有運動員均須自行承擔風險。參加者一經報名，即確認倘於賽事或訓練時發生意外，概不會向參加賽事或訓練的其他運動員行使任何民事訴訟權。

The Show Organiser will provide first aid support to the show. However, Athletes, or their appointed guardian, are solely responsible to make decisions to remount and continue riding in the event of a fall. The Show Organiser recommend a doctor's opinion is sought before continuing to ride.

賽事主辦機構於賽事期間提供急救支援。但是，如運動員在比賽場地墮馬後、**運動員**或**運動員委託的監護人**將有責任去決定是否讓運動員再次上馬及策騎。賽事主辦機構建議運動員在繼續策騎前諮詢醫生的意見。

The Show Organiser is not responsible for the following liabilities:

賽事主辦機構不會承擔以下責任：

- Any decision of an Athlete to remount, and continue riding whether made by the Athlete himself / herself, or his / her parent, guardian, instructor or coach, and regardless of whether a doctor's opinion is sought after a fall.
運動員決定重新上馬並繼續策騎，無論是由運動員本人，還是他/她的父母，監護人，教練或教練，以及是否有在墮馬後尋求醫生的意見。
- Any injuries, diseases, and accidents to the horses, athletes and officials in the time of transportation and during the competition period.
於運送及賽事舉行期間，馬匹、運動員與幹事人員遭遇的任何損傷、疾病及意外。
- Any loss or damages to any third party caused by the participating riders and horses in the time of transportation and during the competition period.
於運送及賽事舉行期間，參加騎手與馬匹對任何第三者構成的損失或損害。

2. EVENT'S ORGANISATION

The Show Director reserves the right to modify the schedule in order to clarify any matters or matters arising from an omission or due to unforeseen circumstances. All modifications made to the schedule prior to the event must have the approval of the Show Director or Secretary General of HKEF (for the Affiliated Classes). Modifications during the event may only be made by the Ground Jury.
