Any member who wishes to compete in local ranking competitions of affiliated shows from 1st September to 31st August will be required to pay a Rider Registration Fee of HK\$ 400 and a Horse Registration Fee of HK\$400 for his or her competition horse before the start of the local ranking competition which he or she has submitted entries to the OC. Affiliated shows refer to shows organized by the HKEF or other riding schools in accordance with HKEF Rules, or in the case of international competitions, under the Rules of the FEI.

#### OTHER REGULATIONS

其他規例

#### 1. Liabilities

All athletes will participate in the Event under their own risk. Their participation confirms their acknowledgement that in case of an accident during the event or a training session they disclaim the enactment of any civil rights which may arise against other athletes participating in the event or the training session.

#### 責任

參加賽事的所有運動員均須自行承擔風險。參加者一經報名,即確認倘於賽事或訓練時發生意外,概不會向參加賽事或訓練的 其他運動員行使任何民事訴訟權。

The Show Organiser will provide first aid support to the show. However, Athletes, or their appointed guardian, are solely responsible to make decisions to remount and continue riding in the event of a fall. The Show Organiser recommend a doctor's opinion is sought before continuing to ride.

#### The Show Organiser is not responsible for the following liabilities:

 Any decision of an Athlete to remount, and continue riding whether made by the Athlete himself / herself, or his / her parent, guardian, instructor or coach, and regardless of whether a doctor's opinion is sought after a fall.

- Any injuries, diseases, and accidents to the horses, athletes and officials in the time of transportation and during the competition period.

#### 2. EVENT'S ORGANISATION

The Show Director reserves the right to modify the schedule in order to clarify any matters or matters arising from an omission or due to unforeseen circumstances. All modifications made to the schedule prior to the event must have the approval of the Show Director or Secretary General of HKEF (for the Affiliated Classes). Modifications during the event may only be made by the Ground Jury.
